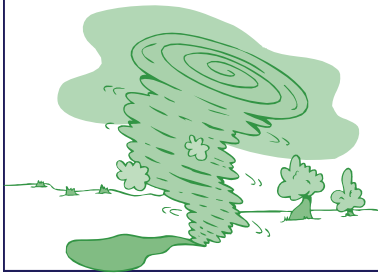
Tornado Safety

Witnessing the horrific loss of life and property damage from the violent weather that recently swept through our area/region brings us to this month's focus, **Tornado Safety**.

Prevention and practice before the storm: Your facility should have a **Tornado Safety Plan** in place with easy-to-read signs posted to direct everyone to a safe, close by shelter area and a pre-determined place to meet after a disaster.

Practice your tornado drills regularly to ensure efficiency and employee familiarity with the plan.

Stay informed: When a tornado watch is issued, **think about the drill** and check to make sure any **safety supplies** that might be needed are handy. **Turn on local TV, radio or NOAA Weather Radio** and stay alert for warnings, especially if you and your employees are unable to hear the city/town Tornado sirens, if available.

OSHA's 'QuickTips' from QuickTakes



Between Feb. 1 and April 30 of each year, most employers must post a summary (OSHA 300A) of the total number of job-related injuries and illnesses that occurred the previous year. This is an excellent time for employers to review their 300 logs and determine where injuries and illnesses are occurring and determine a strategy to reduce, and hopefully eliminate, these safety and health hazards. Recordkeeping is a critical part of an employer's safety and health efforts for several reasons:

- Keeping track of work-related injuries and illnesses can help you prevent them in the future.
- Using injury and illness data helps identify problem areas. The more you know, the better you can identify and correct hazardous workplace conditions.
- You can better administer company safety and health programs with accurate records. As employee awareness about injuries, illnesses, and hazards in the workplace improves, employees are more likely to follow safe work practices and report workplace hazards.
